Question: In regards to proposal requirement, is a reviewed financial statement acceptable?

Clarification: Yes, reviewed financial statements will be accepted. However, because a financial statement review provides a lower level of assurance than an audit, the score awarded will be reflected as such for this requirement.

Question: We have submitted a prequalification questionnaire via Quality Bidders and are waiting for our approval status. Does Little Lake City School District have a deadline set with Quality Bidders for the approval of the District's 2017 prequalification so that LLB Entities awaiting prequalification can receive approval status prior to the February 9, 2017 deadline?

Clarification: As outlined in the RFP, all interested bidders must submit a letter of interest by February 2, 2017 and submit their prequalification package to Quality Bidders by February 9, 2017. The District's deadline to make final prequalification determinations and release an updated listing of prequalified bidders is February 16, 2017.
