OUESTIONS AND CLARIFICATIONS

Question: 1. The license require to bid this project as a prime contractor?

Clarification: The required license information is listed on the General Information section of the RFB.

Question: 2. Is the project still bidding on June 11 at 10:00 AM?

Clarification: Yes.

Question: 3. Is it possible for me to obtain a copy of the sign in sheet after the pre bid meeting on May 23 at 10:00 AM? Could you send me the sign in sheet if there is?

Question: 4. Do you have an updated plan holders list and addenda released at this point? Could you send me if there is?

Clarification: There is no plan holders list at this point. Addendums are posted at the Districts website: https://www.llcsd.net/currentbids.

Question: 5. Do you happen to know how much is the estimate cost of this project?

Clarification: There is no estimate available for this project.

Question: 6. Within the site survey files there are links to pictures. Will these pictures be made available?

Clarification: The links are broken, and we do not anticipate being able to make the pictures available in a usable form.

Question: 7. We missed the Job Walk on May 23rd for this bid as the RPF got to us just a couple of days ago, but would like very much to participate in this project. Is there any way for you to arrange a short visit for us only to one of the schools so that we will be able to participate?

Clarification: Any Contractor bidding on the Project who fails to attend the entire mandatory bid conference and job walk will be deemed a non-responsive bidder and will have its bid returned unopened.

Question: 8. How many lights are in each classroom?

Clarification: 10 in each room 20 total for both.

Question: 9. What is the wattage?

Clarification: The existing fixtures are T-8 32 watts. The new fixtures on the cut sheets are 40 watts.

Question: 10. Being that it is prop 39 is prevailing wage still required?

Clarification: Prevailing wage is required for this project.

Question: 11. Please provide any additional information pertaining the project and step by step instruction for the successful submittal of the estimate.

Clarification: Instructions pertaining to submitting a proposal are found on the Instructions to Bidders section of the RFB.

Question: 12. What are the working hours?

Clarification: This is the time frame for the Prop 39 project.

August 9, 2019: finish project

Question: 13. What is the inspector allowance?

Clarification: There is no inspector allowance. This is not a DSA project.

Question: 14. Will there be an allowance for damaged or brittle fixtures needing to be replaced?

Clarification: All exterior and interior fixtures are to be replaced, so there is no allowance needed for brittle fixture replacements..

Question: 15. If we do ballast bypass on majority of fixtures but on induction fixtures we need to replace the fixtures is that okay?

Clarification: All exterior fixtures are to be replaced with new LED fixtures. All interior pendant lights are to be replaced with new surface-mount LED fixtures. Ballast bypass is not an option.

Question: 16. Is there a lighting schedule and/or manufacture the school prefers?

Clarification: There is not a preferred vendor. Must match items in the lists for size and equivalent or better functionality (light output and operation) and comply with California Energy Commission handbook and audit requirements.
